1 Registry Project

OBJECTIVE To measure actions taken by the national anti-trafficking movement and inspire collaboration among stakeholders with the development of an online database of national organizations fighting modern day slavery.

MILESTONES in 2010

- ✓ Significant progress in timeline with Steering Committee regarding database design, and steps to be taken throughout Phases 2 and 3
- ✓ Committee agreed on guidelines and procedures to ensure project is developed according to the needs, interests and concerns of nationwide organizations;
- ✓ Establishment of procedures to ensure best practices and ethical standards used by participating organizations are reflected in final database;
- ✓ Finalized web host and database programmer;
- ✓ Promoted future database launch among various stakeholders and organizations across the nation;
- ✓ Assisted Chab Dai Canada with preliminary stages of Canada Registry Project.

2 Advocacy & Community Awareness

OBJECTIVE To advocate on behalf of victims and survivors of human trafficking and raise awareness at the local, state-wide, and national level.

MILESTONES in 2010

- ✓ Strengthened partnerships with grassroots movements, regional and nationwide groups raising awareness on human trafficking across the U.S.
- ✓ Participated regularly within local coalitions and networks such as the Sacramento Sacramento Rescue & Restore Art Show
- ✓ Spoke at numerous conferences and panels on national and global issues of trafficking and exploitation
- ✓ Launched “Along the Paths of Justice” curriculum to help educate community members interested in combating human trafficking
- ✓ Hosted and organized the annual Sacramento March Against Slavery with funds distributed to seven local anti-trafficking organizations across Northern California.

Financial Overview

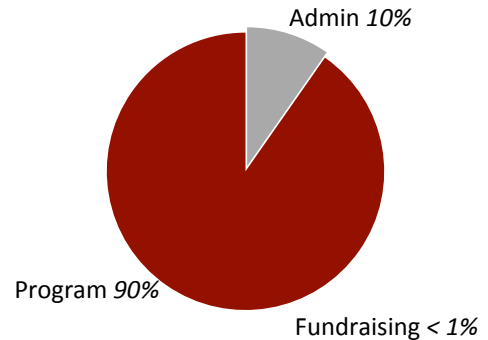
2010 Total Revenue | \$250,282

2010 Total Expense | \$185,590

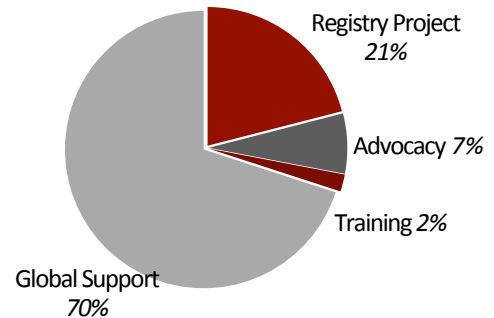

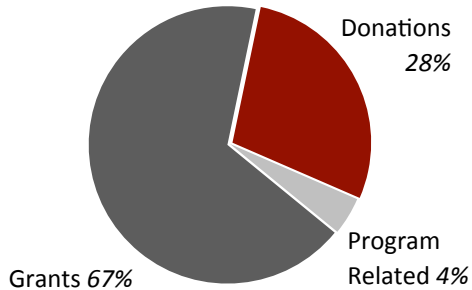
EXPENSE BREAKDOWN
