Founded in Cambodia in 2005, Chab Dai ("joining hands" in Khmer) aims to address human trafficking and exploitation through coalition building, advocacy and research. In addition to our work in Cambodia, Chab Dai has offices in the USA, Canada and UK.

CAMBODIA PROJECTS

Coalition & Member Support

Learning Community

- √ Completed training needs assessments with 265 staff participants representing our coalition members
- ✓ Printed and distributed 327 referral directory booklets and 300 member directories
- ✓ Implemented new library system for members and partners to easily find and check out resources related to their work
- ✓ Added 215 new resources to the resource library, and uploaded 2,089 resources to Freedom Library online
- Distributed 84 newsletters with information regarding opportunities for training, coalition activities, forum meetings, and additional events to over 400 subscribers.

Jeut Nung Dai (Heart & Hands)

- ✓ Over 1,850 participants took part in social work & counseling training, benefiting over 500 member clients
- ✓ Provided direct counseling for 8 clients, including 2 boys
- ✓ Conducted 8 types of capacity building programs, including parenting skills, child development, mental health, advanced counseling and others.
- ✓ Over 22 participants participated in conflict resolution training, with 80% reporting improved ability to help clients address conflict in the family and/or workplace

Charter Doorsteps

- ✓ In 2014, Chab Dai Charter and Doorsteps were combined into one project aimed at seeing participating members improve their capacity & standards in organizational development and project effectiveness
- ✓ 30 member organizations completed their Charter Member Assessments, 3 members completed assessment refreshments, and another 3 are in process
- ✓ Updated our Charter database with manual guidelines videos
- ✓ Delivered 5 types of training with 10 courses in total, and a total of 257 participants trained
- √ 300 participants from churches, partners, members and government attended our Prayer and Advocacy Experiential Conference

CAMBODIA Prevention & Intervention Projects



Safe Community Project

- ✓ Our Safe Community program trained 95 influential community figures and 260 NGO staff on protecting children from trafficking and abuse, who then trained over 2,024 community members in 33 villages and 7 state schools
- ✓ Over 50 cases of rape, trafficking, exploitation, smuggling & unsafe migration were reported as a result of our training
- ✓ Organized 11 live radio shows, broadcasted in 5 provinces educating the public on trafficking, sexual abuse, child rights, unsafe migration and forced marriage. 80 listeners called in to ask questions.

Ethnic Community Prevention

- ✓ Aims to empower ethnic minority communities in Cambodia to protect and intervene on behalf of children at risk of sexual abuse and trafficking.
- ✓ Conducted bilingual training on trafficking, sexual abuse and safe migration with 1,587 community members in attendance, including 787 children.
- ✓ Provided counseling and referral services to victims and their families, including Vietnamese to Khmer translation with the Case Support team.
- ✓ Conducted direct follow-ups with 6 families in ethnic communities to assist them with protecting children from exploitative work environments

Community Heroes

- √ Creates a sustainable and organic basis for preventing trafficking in rural areas of Cambodia by empowering and encouraging existing volunteer trainers (heroes) to protect their communities
- ✓ Conducted refresher course with 80 heroes
- ✓ Our 80 heroes reached 10,436 people in 8 provinces with education on safe migration, trafficking and sexual abuse
- √ Heroes distributed 24,000 help cards, 80 flip charts and 80 t-shirts, all with hotline numbers for community members to use when needing assistance or support

Case Support

- ✓ Provides 24/7 hotline support, referral services and legal support to assist victims of abuse & trafficking
- √ The majority of foreign cases occurred in China, Malaysia, Thailand and Indonesia
- √ Received 258 hotline calls and directly coordinated 168 cases of labor exploitation, trafficking, rape, sexual abuse, smuggling and forced marriage
- ✓ Provided 7 air tickets for repatriation; assisted 42 victims were repatriated from China, 19 from Malaysia and 2 from Thailand
- ✓ Provided 55 cases with legal assistance, 30% of which successfully completed legal proceedings, achieving compensation and justice for victims, including offenders being jailed

Butterfly Longitudinal Research


A longitudinal study examining the (re-)integration process for survivors of sex trafficking in Cambodia over a ten-year period. The overriding objective is to understand (re-)integration from the perspective of survivors themselves.

- ✓ In 2014, we completed our **5th year** of research
- ✓ Updated methodology to reflect focus and priorities of the project
- ✓ Produced both a working paper (directed toward practitioners) and thematic paper (directed toward wider audiences) on "Resilience: Survivor Experiences and Expressions"





Freedom Registry Cambodia

An extension of Chab Dai's original Freedom Registry launched in the U.S. in 2011 & Freedom Collaborative launched as part of the GLC project in 2013

- ✓ In collaboration with our new partner Liberty Asia (Hong Kong), Freedom Registry Cambodia aims to increase national inter-organizational awareness of counter-trafficking programs
- ✓ Uploaded 149 Khmer language resources into Freedom Library
- ✓ Met regularly with Cambodia government agencies, UN agencies and NGO stakeholders to discuss contextualization and implementation of Freedom Registry into Cambodian context
- ✓ FreedomRegistry.org received 1,113 page visits, 8,469 page views and ended the year with over 2,000 international users

Freedom Registry is a directory of vetted counter-trafficking organizations around the globe. Users can update information about their work, and search for other organizations by location, program focus, and direct activities. Add'l tools to be added in 2015.





INTERNATIONAL

Global Learning Community

Launched in 2011, Global Learning Community aims to document and share lessons learned with global counter-trafficking organizations by supporting, coaching, and assisting international stakeholders in multiple sectors.

Achievements in 2014 include:

- ✓ Partnership, capacity-building and knowledge exchange with over 210 partners across 30 countries
- ✓ Expansion of Freedom Collaborative, including an expansion of library functionality, functionality for coalitions, and creation of Freedom Specialists
- ✓ Establishment of a new partnership with Liberty Asia (Hong Kong) who will oversee future technical development of Freedom Collaborative
- ✓ Expanded engagement with the private sector partners
- ✓ Launch of Freedom Dialogues, a series of podcast-like videos meant to share, expand and spur creating thinking about addressing human trafficking

Chab Dai Around the World

In addition to our founding office in Cambodia, Chab Dai has offices in Canada, the United Kingdom and United States.

- ✓ In early 2014, Chab Dai USA restructured its Board of Directors to represent all of Chab Dai's international offices and changed its name to Chab Dai International
- ✓ In the United States, our office in California continued implementation of Freedom Registry, participated in local coalitionbuilding efforts, and provided various training workshops for government offices and non-profits
- ✓ Chab Dai Canada continued planning for the design and implementation of Freedom Registry Canada and participated in local counter-trafficking efforts in Montreal
- ✓ Chab Dai UK continued fundraising efforts for projects in Cambodia, and continued initial discussions about the development of Freedom Registry UK

Chab Dai is committed to modeling the highest of standards in all that we do, and is therefore fully committed to fiscal transparency, accountability, and stewardship.






