Survivor Restoration

Challenge - A lack of effective and consistent long term services where survivors' voices and choices input into their own journey of restoration and that of others.

Change - Survivors of modern slavery and sexual abuse have the freedom and agency to access services, based on their identified short- and long-term restoration plan. Survivors are empowered to bring their voices and experiences to inform and advocate for the healing journey of other survivors.

Community Empowerment

Challenge - A lack of inclusion, connection and access from vulnerable and discriminated communities to protection frameworks and locally led responses.

Change - Families, neighbors and communities are empowered to protect and ensure the safety of one another with the support of NGOs, influencers, local authorities, religious leaders and government.





System Strengthening

Challenge - A lack of trust and collaboration between governments and NGOs on how to create, implement and monitor stronger national laws, frameworks and responses to the issues.

Change - Government entities on both the national and local levels have the knowledge, resources, policy frameworks, and political will to respond effectively and efficiently to cases of modern slavery and sexual abuse.

Movement Building

- **Challenge** A lack of coordination between stakeholders working to address the same issue of human trafficking as well as a lack of lessons learned shared between organizations, and a need for more learning within them.

214 Global Learning Community members in 43 countries

220 participants gathered online from 27 countries, representing over 45 organizations for 2022's ARAT Conference

The Chab Dai Charter assessment tool creates a better understanding of organisational processes, effectiveness and the importance of project and core support teams working together.

A member organisation had **struggled to gain clarity** on all departments' work, particularly being alerted to, and understanding, the challenges that the social workers faced. Using the **Chab Dai Charter assessment tool** they implemented an organisation **improvemnt action plan**, and with Charter team follow up visits they understood how to track their progress. *"We know what we should do and how to work on the action plans for the purpose of making our NGO grow. I did not know the challenges that social workers face in the field, [now I can] see the big picture of the organisation's work, [it] helps us to find the available source to strengthen our capacity".*

2022 was a year of dynamic global growth for the GLC with increased connections, collaborations and an increased membership of over 200 people in over 40 countries all working to combat human trafficking and modern slavery.

- 9 GLC Members signed a joint letter to the US Department of State Office to Monitor & Combat Trafficking in Persons on trafficking in key transit points.
- 30 surveys have been collected for the Survivor Organisation Mapping project led by EverFree, USA, to define and explore survivor-led organisations' role in the movement
- 9 GLC member organisations assisted Everfree in translating and contextualising a survivor well being tool and agreed to pilot the tool in their organisations.

A Community Hero helps prevent two girls from being trafficked.

In the past,when community members needed supporting documents signed to apply for a job, a community leader would always just sign, thinking he was helping people get better paying jobs to support their families. Having been recruited and trained as a Community Hero in 2022, when two families asked him to sign documents stating their two daughters (both under 18) were old enough to go work in Malaysia, he instead **asked questions** and discovered the families had been approached and offered money by a broker they had not met, to take their children to Malaysia. **Realising the risks and dangers of sending their daughters with the broker the families decided not to**. The village leader said, *"If I wasn't recruited for this training, I might have signed for them as I have done in the past. Thanks to Chab Dai for this opportunity."*

A mother shares her family's experience of trafficking and what she has learned from Chab Dai, to a woman who wanted to go to China for an arranged marriage.

In an awareness-raising meeting in the community with selected families, one mother explained that her daughter had been tricked to move to China on the promise of work from a broker, however on arival she was forced to marry a man. **She suffered ongoing abuse, had no freedom or access to money and was not allowed to contact home**. Advising her on how to reach the Cambodian consulate, Chab Dai then coordinated support to get her home. *"Even though it happened to my daughter, I didn't clearly understand what human trafficking is. Now I know (...) it starts with leaving home for a job, facing the tricks of brokers or traffickers, and crossing the border without documents."*

System Strengthening

57 of the 69 officers who attended the training were female

of the police officers scored a high average on the post-training comprehension assessment Provincial Police Working Group in Tboung Khmum Province applied their knowledge from their training to improve effectiveness of their response to cases and report writing for court.

34 police officers who were trained in late 2022. The Deputy of Provincial Police at Tboung Khmum explained that **case processing, in a caring and friendly manner, with clear information gathered now takes only 1-2 hours** when this would take days, with little understanidng of human trafficking. He further said, *"It was such a great honor for them to learn and upgrade their skills and knowledge clearly about identification, investigation, Child-friendly Interviews, and so on. The working group started to have enough capacity to manage their response to the case and there haven't been any more complaints from the court on case processing and documentation."*

Contributing to International System Strengthening through UN engagement. Chab Dai's National Director Dy Noeut, as representative of the Chab Dai Coalition presented at a UN conference in Geneva in September on Accountability and Accessibility to Justice, and Remedies to support survivors of all forms of human trafficking and forced marriage. Numerous experts, academics, researchers, practitioners, and civil society organisations from around the world were invited to join the event where he had a receptive audience. *"I believe the inputs at the event will collectively contribute further to the UN's Resolutions on Human Trafficking."*

Case Support

A survivor of rape, was pressured to change her statement by the family of the accused. Through organisational cooperation between Chab Dai's Case Management Support Project (CMSP), the District Office of Women's Affairs (DOWA) and the Bar Association Legal Aid services who provided free legal support to the survivior and her family, her original statment was readmitted and the two perpetrators were sentenced to five and six years in prison.

Legal Support

The parents of a girl groomed on Facebook and then raped by a neighbor, were hesitant to file a complaint with police because they were unsure of procedure. Chab Dai's Legal Support Project's (LSP) lawyer family to help the family understand their rights and the legal process, and to explain how to claim compensation. They decided to proceed and accompanied by a lawyer they went to trial. The perpetrator was sentenced to 5 years in jail.

Community Based Client Care

After completing her counselling sessions as part of Chab Dai's Community Based Client Care, Kali (not her real name) decided she wanted to help other survivors of trafficking and abuse. She joined the CBCC's Survivor Care Forum and continued to stay in touch with the team reporting issues she saw in her community. She asked to learn more about how to identify cases of trafficking and where to report cases of domestic abuse.

Core Mission Team

We believe working together is the only way to to create change! The amazing work that our direct project staff do to bring dignity, harmony and freedom would not be possible without the dedication and skill of our operations staff who are the core mission team of Chab Dai. These teams work behind the scenes and are usually not spotlighted as key workers in the fight against trafficking, but they are.

Chab Dai UK is registered as a Charitable Incorporated Organisation in the UK (charity #1188067). It is governed by a Board of Trustees, and has representation on the Chab Dai International Board.
